

Failure to provide the requested personal data may result in the University not being able to process your admission application or provide you with the necessary support or assistance during your studies with the University, as the case may be, or even result in your inability to continue or complete study at the University, or failure to enjoy the services, benefits and facilities provided by the University.

**Direct Marketing**

Furthermore, the University may from time to time use your personal data collected through the University's various systems/platforms and other interactions with you in direct marketing. The University may also from time to time provide your personal data to partner institutions with which the University in collaboration jointly offers programs or other opportunities for use in direct marketing.

The personal data the University may use and/or provide to partner institutions for use in direct marketing includes your name, student/alumni number, year of graduation (actual or expected), program of study, employer name, contact details (home/office address, personal/business email address, phone number), enrolment records and demographic data as held by the University and updated from time to time.
